TERMS AND CONDITIONS FOR HIRING OF VEHICLE 2018-2019

01. The Vehicle shall be registered under Commercial Type.
02. Hire vehicle shall remain in the Vidyalaya on 24 hours basis for a period of 10 months in a year (Excluding vacation period i.e. May & June) The tender rate will be valid up to 30.04.2019. from the date of agreement of hire vehicle.
03. The contract will be for a period of 02 years.
04. Vehicle should be hired along with driver from the owner and salary payment to the drive will be done by the owner.
05. JNV will bear only the cost of diesel for the distance actually plied for official use. All other liabilities including wages of driver ,oil and lubricants.maintennance,repair,replacement of parts and servicing obligation on account of Motor Vehicle Act and other related acts like Labour laws,Road tax, Insurance laws (like insurance of vehicles in accident,theft,fire etc.) Shall be the sole responsibility of the owner.
06. Rate to be invited on yearly basis for a period of 10 months in a year.
07. Payments will be made by Vidyalaya on monthly basis.
08. Vehicle will be parked in the Vidyalaya premises only.
09. The Driver of the Vehicle shall be provided accommodation as available on site. Driver of the vehicle will be allowed Mess facility on payment basis.
10. Maximum 1 (One) day per month i.e. 10 days in a year shall be permitted for maintenance/ servicing. The vehicle shall not be sent for repair for more then four days at a stretch. Alternate vehicle shall be provided by the owner in the case of non-availability is for the period exceeding the specific period mentioned above. Failure to provide alternate vehicle shall lead to recovery of actual hiring charges per day of Rs. 1000/- per day, or which ever is higher. In the event of any break down or otherwise ,the vehicle Owner will provide another vehicle or will make alternate arrangement. If the owner of vehicle fails to do so, the Vidyalaya will hire a vehicle for its use solely at the cost of the vehicle owner, and any amount so spent will be adjusted against the Bill of the vehicle owner , and against the performance security.
11. Owner of the vehicle shall furnish a refundable secuity deposit of Rs. 10000/- with the concerned Vidyalaya.
12. The Owner will be responsible for efficient and dilligent service . If the service is not found satisfactory, the Principal shall be at liberty to cancel the contract any time without prior notice to the owner of the same.
13. The owner shall be responsible for proper conduct of the driver, he will have to change the Driver in case the Driver is being reported as improper by the Principal of JNV . The Principal will be at liberty to cancel the contract on this ground also i.e. in case the conduct of the driver is found unsatisfactory without any prior notice of the same to the owner.
14. The year of manufacturing of vehicle shall not be prior to 12.05.2016. the vehicle shall be spacious enough to carry up to 04 person in addition to 1000 Kg. Goods.
